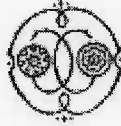

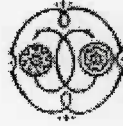
Rejection Criteria

Deviation to the following clauses of tender will lead to rejection of Bid:

- Firm Price
- Unsealed tender envelope.
- Validity of price
- Scope of Work.
- Non fulfilment of requirement of Technical Bid.
- Non fulfilment of conditions in Price Bid.
- Non submission of required documents.
- Any document unsigned and not stamped.
- Any other condition where it is specifically mentioned in the tender document elsewhere that non-compliance will lead to rejection of tender.
- Submission after closing date and time.

Submission of Bids

- Bids must be submitted in a sealed envelope super scribing the tender name "**Repairing and Painting work of Cristal Room, Regal Room and others area.**" and addressing To The CEO , Calcutta Club, 241 A.J.C Bose Road , Kolkata – 700020 , and submit the same along with Bid document within the specified date & time.
- Calcutta Club, at its own discretion, may extend the deadline for submission of the bid, notification of which will be given on its web site. In such scenario, bidder may submit their bid as per the extended deadline.
- Late Bid: Not acceptable.
- Bids will be submitted in two parts – I. Techno-commercial consisting of prequalification compliances along with signed tender document as annexure-1 duly filled and signed , II. Price Bid showing separately GST and replaced old components & accessories.
- In case work order is awarded to the successful bidder and unable to execute/complete within the specified time , 1% will deducted as liquidity damage every week maximum up to 5%.(if Applicable).

BID Opening and Evaluation:

1. BID Opening :
Bids will be opened on the due date and stipulated time in presence of Committee Chairperson.
Confidentiality of Bid Evaluation Process:
 - a. Information relating to examination, evaluation and comparison of Bids and recommendation of award of contract shall not be disclosed to the Bidders or any other interested party. Any effort by the Bidder to influence the bidding process may result in rejection of their Bid.
2. Correction of Errors :
 - a. Bids which have meet all tender terms and conditions will be checked for any arithmetical errors. Errors will be corrected by Calcutta Club in the following manner :-
 - i. Where there is discrepancy between amount in figure and amount in words, the amount stated in word will be considered for the purpose of evaluation and Unit rates of each items will be taken into consideration.
3. Evaluation and Comparison of Bids :
Bidder must quote for all items and exactly as sought in the PRICE BID. Any deviation will result in rejection of Bid.

Award of Contract



2. Calcutta Club reserves the right to accept or reject any Bid or all the Bids at any time prior to the award of contract without assigning any reason to the Bidders or incurring any liability to the affected Bidder(s).

Corrupt & Fraudulent Practices:

1. Calcutta Club requires the bidders/contractors to maintain highest standard of ethics during the bidding process as well as execution of the contract. Definition of corrupt and Fraudulent practices is as follows:-
 - a. "Corrupt practice" means offering or giving anything of value to influence the Club official in procurement process or contract execution.
 - b. "Fraudulent practice "means misrepresentation of facts to influence the procurement process or execution of contract to the detriment of Calcutta Club.
2. Bidders are required to furnish complete and correct information required for evaluation of Bid. If the information/ documents forming part of the Bid is found to be false or forged the same shall be sufficient ground for rejection of Bids. In case, the information/ document submitted by the successful Bidder is found to be false/forged after the award of the contract, Calcutta Club has full right to terminate the contract and get the remaining part of the contract executed at the risk and cost of such agency/ contractor without any prejudice to any other right available to Calcutta Club such as withholding payment etc.

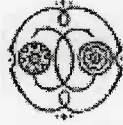
